This course will demonstrate the integration of care by mental health, substance abuse, and medical practitioners. The role of each team member and how they can work together will be described. Strategies will be offered to provide the best evidence-based treatment, the essential skills needed, and ways to create effective teams in order to work within integrated care systems. The interactive educational format will consist of case studies, panel discussions, and individual lectures with q/a. This course is intended for mental health and health practitioners as well as healthcare administrators, policy creators, addiction specialists, and others interested in improved healthcare through carefully coordinated care. **Learning Objectives:** As a result of attending this course participants will be able to: determine how mental health and primary care teams can work together to provide improved access to treatment for children, adults, and families; define key principles of population-based mental health care; incorporate integrated treatments for high-prevalent conditions, such as depression, anxiety, trauma, or addiction; evaluate different interventions used in integrated care settings; and examine the role of technology, and programs for women's health and the seriously mentally ill.
